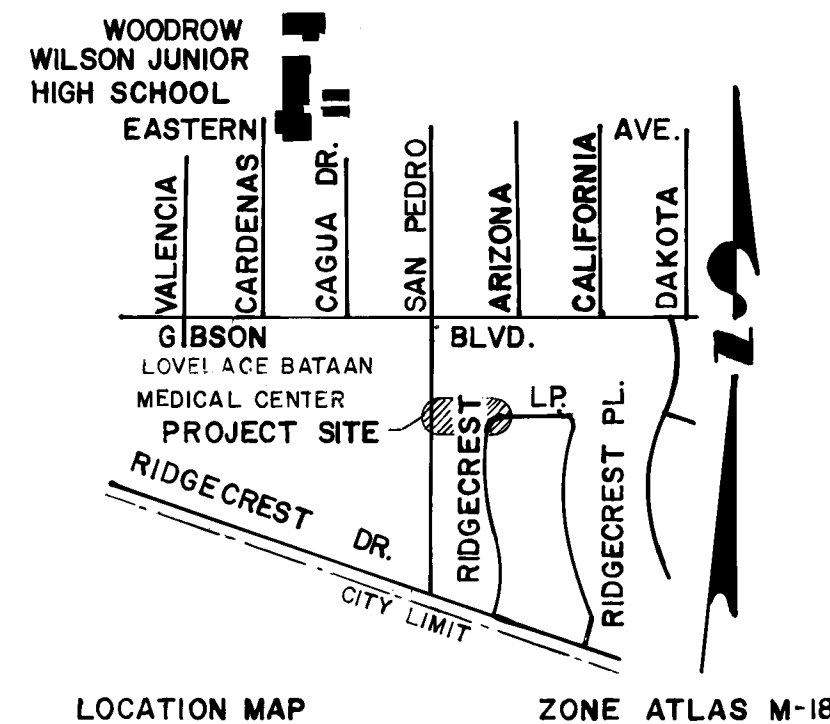


DRAIN AGE IMPROVEMENT EASEMENT BETWEEN SAN PEDRO AND RIDGE CREST SE.

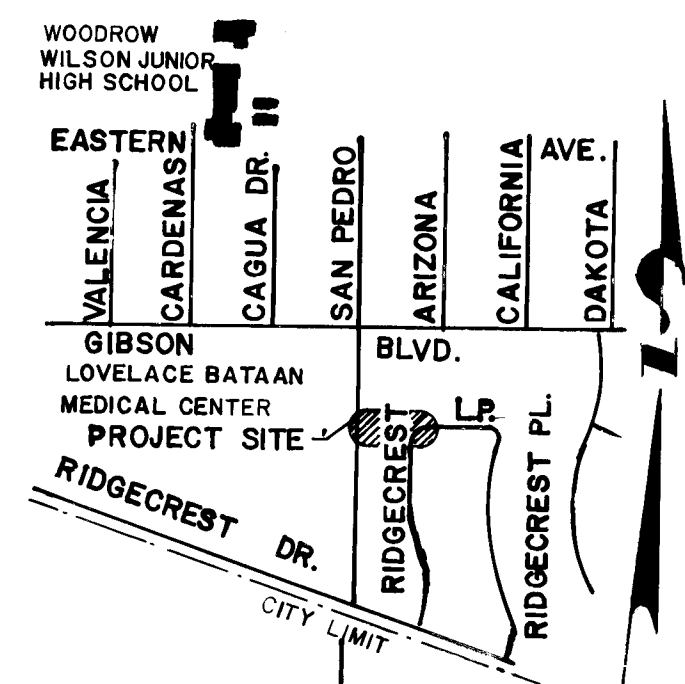
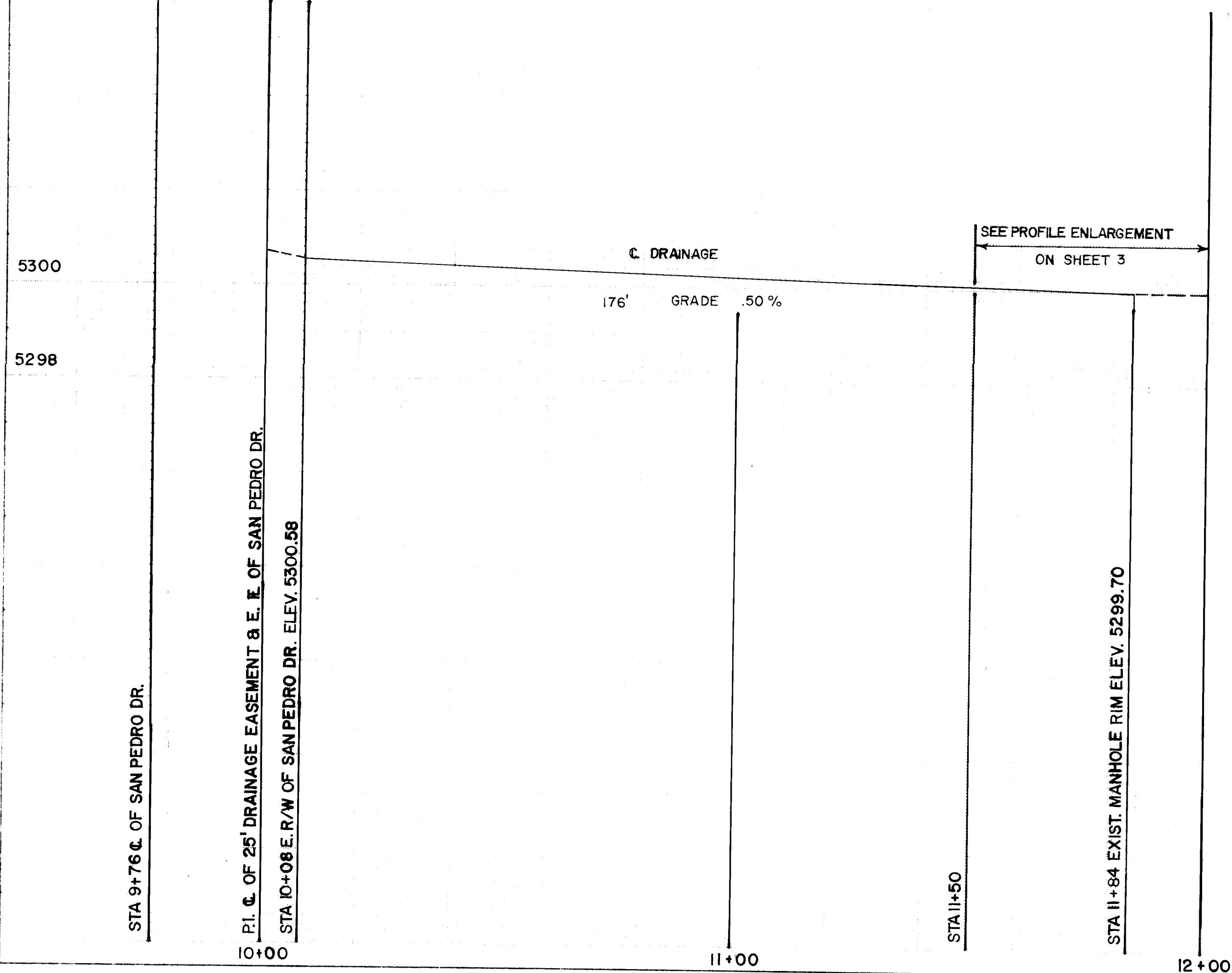
