




GENERAL NOTES

- 1. ALL WORK DETAILED ON THESE PLANS TO BE PERFORMED UNDER CONTRACT SHALL, EXCEPT AS OTHERWISE STATED OR PROVIDED FOR HEREON, BE CONSTRUCTED IN ACCORDANCE WITH THE CITY OF ALBUQUERQUE STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION 1986.
- 2. Two (2) working days prior to any excavation, Contractor must contact line Locating Service @ 260-1990 for Location OF EXISTING UTILITIES.
- 7. TRAFFIC CONTROL: THREE (3) WORKING DAYS PRIOR TO BEGINNING CONSTRUCTION, THE CONTRACTOR SHALL SUBMIT TO THE CONSTRUCTION CO-ORDINATION DIVISION A DETAILED CONSTRUCTION SCHEDULE. TWO (2) WORKING DAYS PRIOR TO CONSTRUCTION, THE CONTRACTOR SHALL OBTAIN A BARRICADING PERMIT FROM THE CONSTRUCTION CO-ORDINATION DIVISION. CONTRACTOR SHALL NOTIFY BARRICADE ENGINEER (768-2551) PRIOR TO OCCUPYING AN INTERSECTION. SEE SECTION 19 OF THE SPECIFICATIONS.
- ALL STREET STRIPING ALTERED OR DESTROYED SHALL BE REPLACED IN KIND BY CONTRACTOR TO LOCATION AND IN KIND AS EXISTING OR AS INDICATED BY THIS PLAN SET.
- 4. ALL WORK NOTED ON THESE PLANS FOR WHICH THERE IS NO RELATED PAY ITEM SHALL BE INCIDENTAL TO CONSTRUCTION AND NO SEPARATE PAYMENT SHALL BE MADE THEREFORE.
- 5. ALL PIPE BEDDING SHALL BE CLASS II OR CLASS III EXCEPT AS NOTED BY NOTE 6. SHEET 3.
