



GENERAL NOTES

1. All work detailed on these plans to be performed under contract shall, except as otherwise stated or provided for herein, be constructed in accordance with the City of Albuquerque Standard Specifications for Public Works Construction 1986 Edition as amended with Update No. 6.
2. All work on this project shall be performed in accordance with applicable federal, state, and local laws, rules, and regulations concerning construction safety and health.
3. Prior to construction, the Contractor shall excavate & verify the horizontal and vertical locations of all obstructions. Should a conflict exist, the Contractor shall notify the Engineer so that the conflict can be resolved with minimum delay.
4. Two (2) working days prior to any excavation, Contractor must contact New Mexico One Call System, Inc @ 260-1990 for location of existing utilities.
5. Contractor shall conduct his operations in a manner which will minimize interference with local traffic. Contractor shall comply with all applicable laws, ordinances, rules, regulations, and orders of any public body having jurisdiction for the safety of persons and property, and shall protect them from damage, injury, or loss. Contractor shall erect and maintain, as required by the conditions and progress of the work, all necessary safeguards for safety continuously and not limited to normal working hours, throughout the duration of the project. Contractor shall adhere to Section 19 of the General Conditions of the City of Albuquerque Standard Specifications for Public Works Construction, 1986, as amended with Update No. 6.
6. The Contractor agrees that he shall assume the sole and complete responsibility for the job site conditions during the course of construction of this project, including safety of all persons and property; that this requirement shall apply continuously and not be limited to normal working hours; and that the Contractor shall defend, indemnify, and hold harmless the Owner & Engineer from any and all liability real or alleged, in connection with the performance of work on this project, excepting liability arising from the sole negligence of the Owner or Engineer.
7. TRAFFIC CONTROL: Three (3) working days prior to beginning construction the Contractor shall submit to the Construction Coordination Division a detailed construction schedule. Two (2) working days prior to construction, the Contractor shall obtain a barricading permit from the Construction Coordination Division. Contractor shall notify Barricade Engineer (768-2551) prior to occupying any intersection. See section 19 of the specifications. All street striping altered or destroyed shall be replaced by Contractor to location and in kind as existing at no additional cost to the Owner. All existing signs, markers, delineators, etc., within the construction limits shall be removed, stored, and re-set by the contractor.
8. When abutting existing pavement to new, sawcut existing pavement to a straight edge and at a right angle, or as approved by the field Engineer. Removal of broken or cracked pavement will also be required.
9. Existing curb and gutter not to be removed under the contract which is damaged or displaced by the Contractor shall be removed and replaced by the Contractor at his expense.
10. All final backfill for trenches shall be compacted to a minimum 90% maximum density per ASTM D-1557 and as directed by section 701.14.2 and standard drawing number 2315.
11. The Contractor shall promptly clean up any material excavated within the public right of way so that the excavated material is not susceptible to being washed down the street or into any public drainage facility.
12. Proposed waterline materials shall be either PVC pipe meeting AWWA C900 requirements (6" - 8") or ductile iron pipe, thickness class 50 (6" - 8").
13. All sanitary sewer line stationing refers to sanitary sewer centerline stationing.

A CERTAIN TRACT OF LAND, BEING AND COMPRISING TRACTS 238 & 239, TOWN OF ATRISCO GRANT, AIRPORT UNIT, AS THE SAME IS SHOWN AND DESIGNATED ON THE PLAT THEREOF, FILED IN THE OFFICE OF THE COUNTY CLERK OF BERNALILLO COUNTY, NEW MEXICO ON DECEMBER 5, 1944 IN VOL D, FOLIO 118, LESS AND EXCEPTING THAT PORTION TAKEN FOR THE ACCESS RAMP FROM I-40 TO UNSER BOULEVARD N.W. AS SHOWN ON NEW MEXICO STATE HIGHWAY COMMISSION RIGHT-OF-WAY MAP I-40-3(28)148, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID TRACT HEREIN DESCRIBED, WHENCE A.C.S. CONTROL STATION 3-H10 BEARS N 00°50'06" W, 1806.54 FEET DISTANT, BEING A POINT ON THE SOUTHERLY RIGHT-OF-WAY OF HANOVER ROAD N.W.; THENCE, FROM SAID POINT OF BEGINNING S 89°20'53" E, 420.90 FEET ALONG SAID SOUTHERLY RIGHT-OF-WAY TO THE NORTHEAST CORNER OF SAID TRACT; THENCE, LEAVING SAID SOUTHERLY RIGHT-OF-WAY, S 00°37'41" W, 1025.68 FEET TO THE SOUTHEASTERLY CORNER OF SAID TRACT, BEING A POINT ON A CURVE ON THE SOUTHEASTERLY RIGHT-OF-WAY OF THE ACCESS RAMP FROM I-40 TO UNSER BOULEVARD N.W. THENCE, ALONG SAID NORTHEASTERLY RIGHT-OF-WAY, NORTHEASTERLY ALONG A CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 41°38'12", HAVING A RADIUS OF 680.32 FEET, AND AN ARC LENGTH OF 494.39 FEET, TO THE SOUTHWEST CORNER OF SAID TRACT; THENCE, LEAVING SAID NORTHEASTERLY RIGHT-OF-WAY, N 00°26'13" E, 783.20 FEET TO THE POINT OF BEGINNING, CONTAINING 9.0393 ACRES, MORE OR LESS.

PUBLIC UTILITY EASEMENTS

PUBLIC UTILITY EASEMENTS shown on this plat are granted for the common and joint use of:

1. PNM Electric Services Division for the installation, maintenance, and service of overhead and underground electrical lines, transformers, poles and any other equipment, fixtures, structures and related facilities reasonably necessary to provide electrical services.

2. PNM Gas Services Division for installation, maintenance, and service of natural gas lines, valves and other equipment and facilities reasonably necessary to provide natural gas services.

3. U.S. West for installation, maintenance and service of all buried and aerial communication lines and other related equipment and facilities reasonably necessary to provide communication services, including but not limited to above ground pedestals and enclosures.

4. Jones Intericable for the installation, maintenance, and service of such lines, cable, and other related equipment and facilities reasonably necessary to provide cable TV services.

Included, is the right to build, rebuild, construct, reconstruct, locate, relocate, change, remove, modify, renew, operate, and maintain facilities for the purposes described above, together with free access to, from, and over said easements, including sufficient working area space for electric transformers, with the right and privilege to trim and remove trees, shrubs or bushes which interfere with the purposes set forth herein. No building, sign, pool (aboveground or subsurface), hot tub, concrete or wood pool decking, or other structure shall be erected or constructed on said easements, nor shall any well be drilled or operated thereon. Property owners shall be solely responsible for correcting any violations of the National Electrical Safety Code caused by construction of pools, decking, or any structures adjacent to within or near easements shown on this plat.

In approving this plat, the utility companies listed above did not conduct a title search of the properties shown herein. Consequently, the utility companies do not waive or release any easement or easement rights which may have been granted by prior plat, replat or other document and which are not shown on this plat.
