5. PURPOSE OF PLAT This plat has been prepared for the purpose of creating two tracts from one tract and granting of easements.

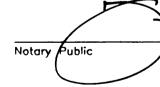

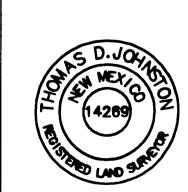

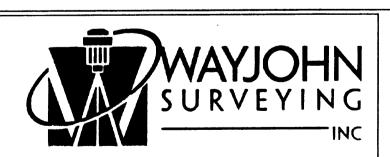
