DESCRIPTION

TRACT 1

That certain parcel of land situate within the Town of Albuquerque Grant, City of Albuquerque, Bernalillo County, New Mexico, comprising a portion of the Right-of-Way of Cedar Street, S.E., as shown on the plat entitled "Amended Map of THE TERRACE ADDITION To The City of Albuquerque," as filed in the Office of the Probate Clerk and Recorder of Bernalillo County, Territory of New Mexico on November 15, 1910 in Book C2, Page 71 and being more particularly described as follows:

Beginning at a point on the east right-of-way line of the said Cedar Street, S.E.,; Whence the northeast corner of Lot 1, Block 28 of the said Amended Terrace Addition bears N 09° 08' 55" E, 8.00 feet;

Thence S 81° 03' 05" E, 32.48 feet to a point of curvature (PC); Thence southeasterly 41.45 feet along the arc of a curve to the right, said curve having a radius of 25.00 feet, a central angle of 95° 00' 04" and a chord which bears S 33° 33' 02" E, 36.86 feet to a point of tangency (PT); Thence S 13° 57' 00" W, 14.28 feet to a point of curvature (PC); Thence southwesterly 76.32 feet along the arc of a curve to the right, said curve having a radius of 178.21 feet, a central angle of 24° 32' 19" and a chord which bears S 26° 13' 09" W, 75.74 feet to a point of reverse curvature (PRC); Thence southwesterly 39.06 feet along the arc of a curve to the left, said curve having a radius of 250.42 feet, a central angle of 8° 56' 15" and a chord which bears S 34° 01' 11" W, 39.02 feet to a point of reverse curvature (PRC); Thence southwesterly 15.79 feet along the arc of a curve to the right said curve having a radius of 13.00 feet, a central angle of 69° 35' 52" and a chord which bears S 64° 20' 59" W, 14.84 feet to a point of tangency (PT); Thence N 80° 51' 05" W, 5.47 feet to a point on the said westerly right-of-way line of Cedar Street, S.E.; Thence N 09° 08' 55" E, 157.50 feet along the said right-of-way line to the point of beginning of the parcel herein described.

Beginning at the northwest corner of the said Lot 6 of Block 29, whence the northeast corner of Lot 1, Block 28 of the said Amended Terrace Áddition bears N 81° 03' 05" W, 60.00 feet;

Thence S 81° 03' 05" E, 87.11 feet along the north property lines of said Lots 5 and 6, Block 29 (said property lines being the same as the south right-of-way line of East Central Avenue) to a point of cusp; Thence southwesterly 18.44 feet along the arc of a curve to the left, said curve having a radius of 12.43 feet, a central angle of 84° 59' 55" and a chord which bears S 56° 26' 58" W, 16.79 feet to a point of tangency (PT);

Thence S 13° 57' 00" W, 44.77 feet to a point of curvature (PC); Thence southwesterly 108.36 feet along the arc of a curve to the right, said curve having a radius of 253.21 feet, a central angle of 24° 31' 06" and a chord which bears S 26° 12' 33" W, 107.53 feet to a

point of tangency (PT); Thence S 38° 28' 06" W, 38.75 feet to a point of curvature; Thence southwesterly 81.88 feet along the arc of a curve to the left, said curve having a radius of 160.00 feet, a central angle of 29° 19' 12" and a chord which bears S 23° 48' 31" W, 80.99 feet to a point of cusp on the easterly right-of-way line of Cedar Street, S.E.; Thence N 09° 08' 55" E, 270.63 feet along the said easterly right-of-way line of Cedar Street, S.E. to the point of beginning of the parcel herein described.
