Plat Notes (03/14/1996, 96C-120)

- A. THE CITY RETAINS A SLOPE EASEMENT OVER THE VACATED PORTIONS OF EDITH BOULEVARD. THE OWNER OF THE PROPERTY AGREES TO MAINTAIN THE SLOPE EASEMENT AREA IN A MANNER SO THAT THE SLOPE DOES NOT DETERIORATE AND/OR ERODE IN A MANNER WHICH INTERFERES WITH THE OPERATION OF EDITH BOULEVARD. 
