

DESCRIPTION

A certain tract of land situate within Section 5, Township 10 North, Range 3 East, N.M.P.M., Albuquerque, Bernalillo County, New Mexico, being known as Lots numbered Two (2) and Three (3), Block lettered "C", of the DAVIDSON ADDITION, as the same is shown and designated on the Map of said Addition, filed in the Office of the County Clerk of Bernalillo County, New Mexico, on September 12, 1923, in Plat Book D1, folio 38, and being more particularly described as follows:
