A CERTAIN PARCEL OF LAND SITUATE IN THE CITY OF ALBUQUERQUE. BERNALILLO COUNTY. NEW MEXICO. BEING WITHIN SECTION 18. TOWNSHIP 10 NORTH. RANGE 3 EAST. NEW MEXICO PRINCIPAL MERIDIAN. AND BEING IDENTIFIED AS ALL OF TRACT 51. AND A NORTHERLY PORTION OF TRACT 52 (ALSO KNOWN AS TRACT 52A). AS SHOWN ON THE MIDDLE RIO GRANDE CONSERVANCY DISTRICT PROPERTY MAP NO. 38. AND LOT 10. BLOCK I. THE ROEHL'S GARDEN ADDITION TO THE CITY OF ALBUQUERQUE, BERNALILLO COUNTY, NEW MEXICO, AS THE SAME IS SHOWN AND DESIGNATED ON THE PLAT FILED IN THE OFFICE OF THE PROBATE CLERK AND EX-OFFICIO RECORDER OF BERNALILLO COUNTY. FROM WHENCE ALBUQUERQUE CONTROL MONUMENT 14-JI3 BEARS N 84*37*55*W (GRID). 975.85 FEET (GROUND): THENCE ALONG THE COMMON LINE WITH LOT II. BLOCK I. OF SAID THE ROEHL'S GARDEN ADDITION. N 88°34'32"E. 108.04 FEET TO THE NORTHEAST CORNER OF SAID LOT 10. BLOCK I. THE ROEHL'S ADDITION. SAID CORNER BEING COMMON WITH THE SOUTHEAST CORNER OF SAID LOT 11. BLOCK D AND ALSO BEING A POINT ON THE WEST RIGHT OF WAY LINE OF 19th STREET N.W..


