LEGAL DESCRIPTION

A certain tract of land comprising all of Lots numbered Eighteen (18), Nineteen (19), Twenty (20) and Twenty-one (21) in Block numbered Four (4) of BELMONT PLACE, an Addition to the City of Albuquerque, as the same is shown and designated on said plat thereof filed in the office of the County Clerk of Bernalillo County, New Mexico on January 23, 1924 in Vol. B2, folio 34; TOGETHER with vacated portions of the right-of-way of Belrose Avenue N.W. and 5th Street N.W. as approved by the City of Albuquerque Development Review Board as Project No. 1002468. Said entire tract of land being more particularly described by metes and bounds survey as follows:

Beginning at the southwest corner of the tract herein described, whence the N.M.S.H.C. Station "NM 47-10" bears S.32°33'35"E., 2313.64 feet distant; thence, N.09°19'27"E., 104.41 feet to the northwest corner of the tract herein described, being the northwest corner of said Lot 18, Block 4, BELMONT PLACE; thence, S.76°13'33"E., 146.36 feet to the northeast corner of the tract herein described; thence, S.09°19'27"W., 82.80 feet to a point of curvature; thence, southwesterly, along a curve to the right with a radius of 20.00 feet, an arc length of 13.44 feet, a central angle of 38°30'36" and a chord bearing \$.28°34'45"W., 13.19 feet to a point; thence, S.09°19'27"W., 4.41 feet to the southeast corner of said Lot 21, Block 4, BELMONT PLACE; thence, N.76°13'33"W., 4.40 feet to a point on curve; thence, southwesterly, along a curve to the right with a radius of 20.00 feet, an arc length of 13.52 feet, a central angle of 38°44'22" and a chord bearing S.84°24'16"W., 13.27 feet to a point of tangency; thence, N.76°13'33"W., 124.75 feet to the point of beginning.




