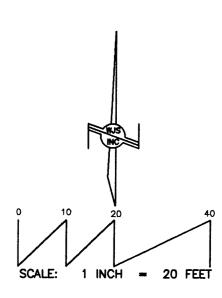


PLAT OF LOTS 1, 2, 3, 4, 5, AND 6 ZUNI TOWNHOMES

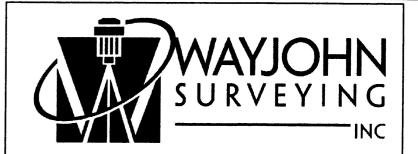

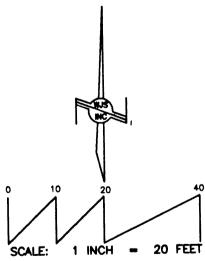


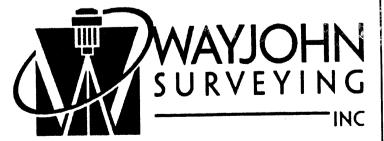
PLAT OF LOTS 1, 2, 3, 4, 5, AND 6 ZUNI TOWNHOMES

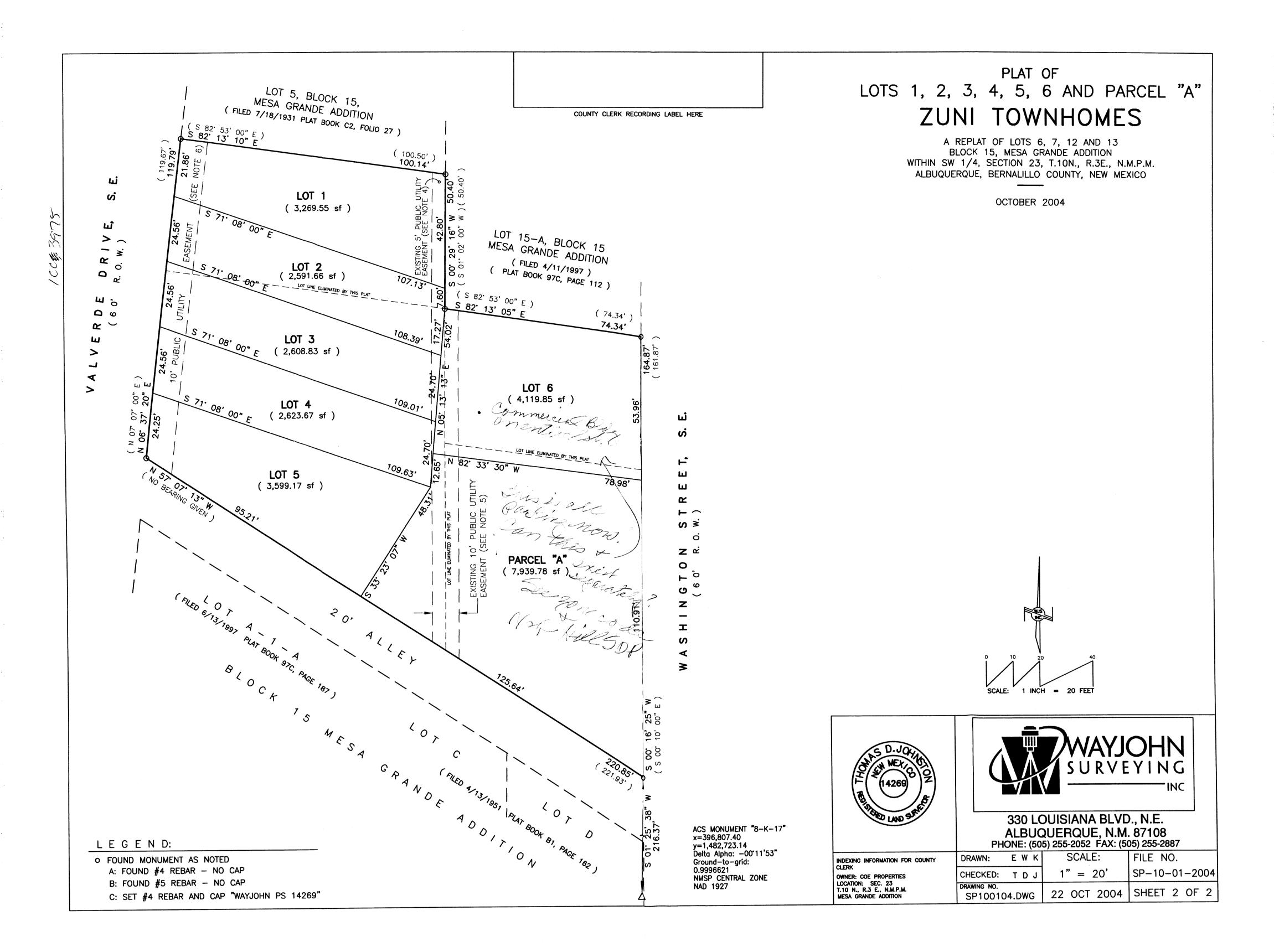


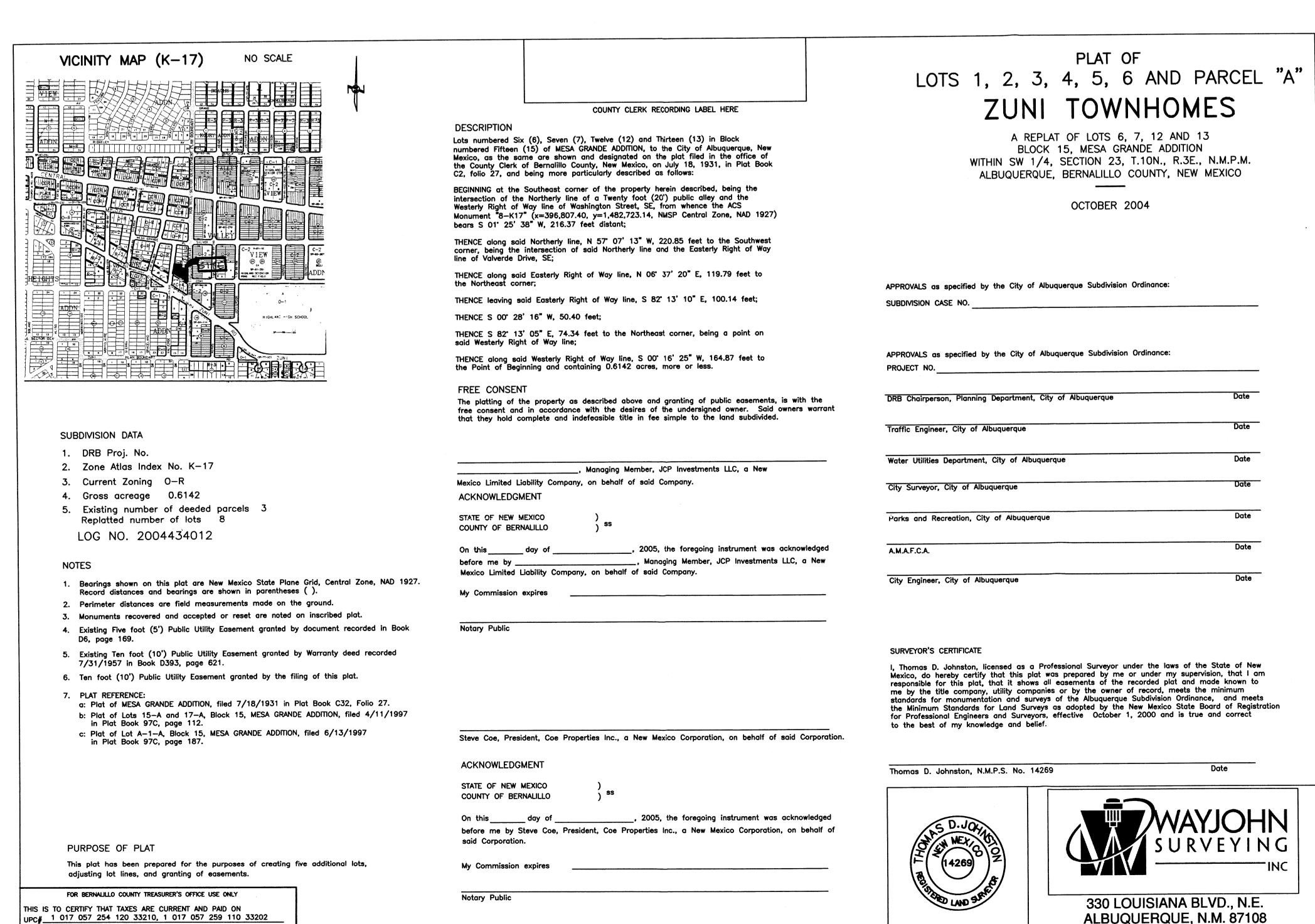
