PUBLIC UTILITY EASEMENTS shown on this plat are granted for the common and joint use of:

- A. Public Service Company of New Mexico ("PNM"), a New Mexico corporation, (PNM Electric) for installation, maintenance, and service of overhead and underground electrical lines, transformers, and other equipment and related facilities reasonably necessary to provide electrical services.
- New Mexico Gas Company for installation, maintenance, and service of natural gas lines, valves and other equipment and facilities reasonably necessary to provide natural gas services.
- C. Qwest for the installation, maintenance, and service of such lines, cable, and other related equipment and facilities reasonably necessary to provide communication services.
- D. Cable TV for the installation, maintenance, and service of such lines, cable, and other related equipment and facilities reasonably necessary to provide Cable services.

Included, is the right to build, rebuild, construct, reconstruct, locate, relocate, change, remove, replace, modify, renew, operate and maintain facilities for purposes described above, together with free access to, from, and over said easements, with the right and privilege of going upon, over and across adjoining lands of Grantor for the purposes set forth herein and with the right to utilize the right of way and easement to extend services to customers of Grantee, including sufficient working area space for electric transformers, with the right and privilege to trim and remove trees, shrubs or bushes which interfere with the purposes set forth herein. No building, sign, pool (aboveground or subsurface), hot tub, concrete or wood pool decking, or other structure shall be erected or constructed on said easements, nor shall any well be drilled or operated thereon. Property owners shall be solely responsible for correcting any violations of National Electrical Safety Code by construction of pools, decking, or any structures adjacent to or near easements shown on this plat.

Easements for electric transformer/switchgears, as installed, shall extend ten (10) feet in front of transformer/switchgear doors and five (5) feet on each side.

AThat certain parcel of land situate within the Town Of Atrisco Grant in Projected Section 15, Township 10 North, Range 2 East, New Mexico Principal Meridian, City of Albuquerque, Bernalillo County, New Mexico, comprising Lot 10 and portions of Lots 9 thru 6, Block L, Northern Heights and a vacated portion of El Vado Drive as the same is shown and designated on the plat entitled "BLOCKS J, K & L, NORTHERN HEIGHTS, A SUBDIVISION, ALBUQUERQUE, NEW MEXICO, SCALE: 1IN.= 100FT.", filed in the office of the County Clerk of Bernalillo County, New Mexico, on June 14, 1947, in Volume B, Folio 71, and Tract Q, Atrisco Business Park, Unit No. 2, as the same is shown on the plat entitled "REPLAT OF TRACT Q OF UNIT NO. 2, ATRISCO BUSINESS PARK, WITHIN PROJECTED SEC. 15, T.10N., R.2E., CITY OF ALBUQUERQUE, NEW MEXICO, SEPT., 1984", filed in the office of the County Clerk of Bernalillo County, New Mexico, on April 1, 1985, in Volume C26, Folio 171, more particularly described by survey performed by Russ P. Hugg, New Mexico Professional Surveyor Number 9750, using New Mexico State Plane Grid Bearings (Central Zone - NAD 83) and ground distances as follows:

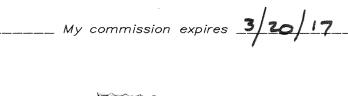

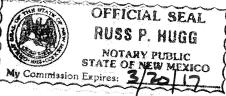
