A tract of land lying and situate within Section 12, Township 10 North, Range 2 East, N.M.P.M., Bernalillo County, New Mexico, comprising of a portion of Tract 36B1 as the same is shown and designated on Property Map No. 35 of the Middle Rio Grande Conservancy District, less than and excepting that Portion of said Tract that was declared a public road by order of Judge Bert Cosgrove, CV-93-6839 filed February 25, 1994 and as shown on "Public Road Plat" filed on February 25, 1994 in Volume 945, Folio 6, said remaining tract being more particularly described as follows:

Beginning at the Southeast Corner of said Tract from whence a tie to ACS Monument "8-H13" bears S 61°19'51" E, a distance of 3,582.59 feet;

Thence from said beginning point N 77°58'40" W, a distance of 347.33 feet to the Southwest Corner of said Tract lying on the East right of way line of Gabaldon Road;

Thence N 04°39'19" E, along said East right of way line, a distance of 103.18 feet to the Northwest Corner of said Tract and a point on the South line of Moya Road;


Thence S 79°39'43" E, along said South line, a distance of 365.75 feet to the Northeast Corner of said Tract;

Thence S 14°33'26" W leaving said right of way, a distance of 96.99 feet to an angle point;

Thence S 14°38'07", a distance of 16.21 feet to the point of beginning, containing 0.8819 acres, more or less.


