LEGAL DESCRIPTION

Lots numbered Ten (10), Eleven (11) and Twelve (12) in Block Numbered Fifty-Five (55) of the New Mexico Town Company's Original Townsite of Albuquerque, New Mexico within Section 18, T10N, R3E., N.M.P.M., City of Albuquerque, Bernalillo County, New Mexico, as the same are shown and designated on the plat thereof, filed in the office of the County Clerk of Bernalillo County, New Mexico on December 29, 1962, in Book D Page 140 and being more particularly described as follows:

Beginning at the northwest corner of the herein described tract; said northwest corner also lying on the south margin of Tijeras Avenue N.W.; whence City of Albuquerque Control Station "12_J13" having New Mexico State Plane Coordinates of (Central Zone, NAD 1983) Northing= 1,489,275.084 and Easting= 1,517,168.520 bears N25°27'31"W, a distance of 1,845.31 feet running thence S78°50'57"E along said south margin, a distance of 75.09 feet to the northeast corner; thence S08°23'54"W leaving said south margin, a distance of 154.53 feet to the southeast corner; said southeast corner also lying on the north margin of Kent Avenue N.W.; thence N82°21'51"W along said north margin, a distance of 75.01 feet to the southwest corner; said southwest corner also lying on the east margin of Eleventh Street N.W.; thence N08°23'54"E along said east margin, a distance of 159.13 feet to the northwest corner and place of beginning, containing 0.2634 Acres more or less.
