Infrastructure List Revision

RESPEC, agent for RCS – Taos, LLC, is requesting a change to the Infrastructure List for Lots 1-56 of Taos at the Trails Unit 1. (See "Related Filings" below).

We are requesting that the Development Review Board approve the removal of the ¼ traffic signal at the intersection of Universe and Woodmont from the Infrastructure List. Based on High Mesa Consulting Group's "Traffic Signal Warrant Study- Universe Blvd and Woodmont Ave Intersection" dated October 24, 2017 and the meeting on January 26, 2018 with the City Engineer, DRB Chair, and Transportation staff, a traffic signal is not warranted at this intersection.
