

A certain parcel of land in Section 23, Township 10N, Range 3E, NMPM, located within Lot 13, Block 4 of Mesa Grande Addition, an addition to the City of Albuquerque, as the same is shown and designated on the Plat filed in the Office of the County Clerk of Bernalillo County, New Mexico on July 18, 1931 in Volume C2, Folio 27, and further described by New Mexico State Plane grid bearings and ground distances as follows:

Beginning at the Southeast corner of lot 13, a chiseled "X" found in the sidewalk, from whence the City of Albuquerque Survey Control Monument "5-K17A" having New Mexico State Plane Coordinates (Central Zone) of X=395645.50 and Y=1484196.72 bears 86°45′ 43" W a distance of 1175.68 feet;

Thence along the South line of lot 13, N 82°14' 05" W a distance of 47.73 feet to the Southwest corner of lot 13;

Thence S 89 ° 39' 03" E, a distance of 7.00 feet to a point on the East line of lot 13, being also the Northeast corner of the parcel herein described;

Thence along the East line of lot 13, S 00 ° 20' 57" W a distance of 37.30 feet to the point of beginning and containing 697 square feet (0.0160 acres) more or less.





Beginning at the Southeast corner of 12, from whence the City of Albuquerque Survey Control Monument "5-K17A" having New Mexico State Plane Coordinates (Central Zone) of X=395645.50 and Y=1484196.72 bears N 86° 57' 12" W a distance of 1128.10 feet;

Thence along the south line of lot 12, N 82° 14' 05" W a distance of 6.69 feet to the Southwest corner of the parcel herein described;

Thence N 07° 45' 55" E, a distance of 10.93 feet to the Northwest corner of the parcel herein described;

Thence S 82° 14' 05" E, a distance of 6.69 feet to a point on the East line of lot 12, being also the Northeast corner of the parcel herein described;

Thence along the East line of lot 12, S 07° 45′ 55" W a distance of 10.93 feet to the point of beginning and containing 73 square feet (0.0017 acres) more or less.
