Purpose of Plat

THE PURPOSE OF THIS REPLAT IS TO VACATE AN ALLEY, CONSOLIDATE TWELVE EXISTING LOTS AND THE VACATED ALLEY INTO FOUR NEW LOTS AND GRANT A PUBLIC UTILITY EASEMENT ACROSS VACATED ALLEY.
