Dear Mr. Cloud,

On behalf of our clients request the referenced/above vacation of the remaining 16' alley in Block A, Atlantic and Pacific Addition located between 1st and 2nd Streets and Coal and Iron Avenues, SW.

This is a request for vacation of public right of way for remnants of an alley in the Barelas neighborhood. The platted right of way abuts property under 4 different ownerships, and all are in agreement to close the alley. The applicants for this request are John Yost ("Yost"), Rahim and Nizar Kassam ("Kassam"), Russell Garner, Rodney Guarneri, and Richard Guarneri ("Garner/Guarneri") and Fred and Daisy Austin ("Austin"). Yost, Kassam, Garner/Guarneri and Austin are jointly referred to herein as the "Owners".

On December 10, 2014, the Development Review Board held an advertised public hearing on the proposed vacation. After concluding it public hearing, the Board recommended approval to the City Council of the proposed vacation. The "Owners" did not complete the replat process within the one-year time frame, so the request is being made again in conjunction with the replat.
