Quest Network, LLC is performing a replat survey on Lots 1 and 3 of Los Tomases Addition, at the request of the property owner, Mr. Jaime Trujillo, for the purposes of combining Lot 1 and Lot 3 into one lot. The address of Lot 1 is 813 Phoenix Avenue, N.W., and the address of Lot 3 is 2905 8th Street, N.W., which the main portion of the residence resides on. This replat will allow Mr. Trujillo to make improvements to his property and add an addition to the existing residence. The back portion of residence currently crosses the line between the two lots, and no additions or improvements will be allowed by the City of Albuquerque without the consolidation of the lots.

In performing the survey, we discovered an encroachment of the existing covered patio, walkway concrete and a shed onto an existing utility easement created by the Los Tomases Addition subdivision plat, filed on January, 20, 1959, in Volume C4, Folio 63. This 10 foot wide easement runs at an angle through Lot 1 and terminates at the division line between Lots 1 and 3. As part of our survey, we had a NM One Call utility line location performed on the entire property to locate any utility lines in use within this easement. The findings show that there are no utilities within said easement so we are requesting a vacation of this easement to eliminate the current encroachments.

There is an overhead utility line running along the north side of Lot 3, with a street light on the east side and a utility pole with an anchor on the west side of the line. As part of our platting action, to combine the lots and eliminate easement encroachments, we are creating a new easement for this portion of the overhead utility line for utility company access.






