Previous Comments:

- 1. Infrastructure list should include all frontage improvements including ¼ signal.
- 2. Perform an overall quality control check. (Street names are missing, dimensions are obscured, keyed notes are very large, PNM easement looks like an access etc.)
- 3. Please add a note on the plan stating "All improvements located in the Right of Way must be included on a public work order."
- 4. Please add the clear sight triangle to each subdivision entrance. Add the following note as well: "Landscaping, fencing and signing will not interfere with clear sight requirements. Therefore, signs, walls, trees, and shrubbery between 3 and 8 feet tall (as measured from the gutter pan) will not be acceptable in the clear sight triangle."
- The ADA access aisle shall have the words "NO PARKING" in capital letters, each of which shall be at least one foot high and at least two inches wide, placed at the rear of the parking space so as to be close to where an adjacent vehicle's rear tire would be placed. (66-1-4.1.B NMSA 1978)
- 6. List the number of parking spaces required by the zoning code as well as the proposed number of parking spaces including bicycle and motorcycle parking.
- 7. Identify all existing access easements and rights of way width dimensions.
- 8. Clarify existing property lines and proposed property lines. Provide plat.
- 9. Please list the width and length for all existing and proposed parking spaces. Some dimensions are not shown.
- 10. Per the zoning code, a 6 ft. wide ADA accessible pedestrian pathway is required from the public sidewalk to the building entrances. Please clearly show this pathway and provide details.
- 11. Add parking bumpers where the curb ramp is located. Show where the curb ramp is located.
