


Good afternoon Shahab, Ernest, and James:


For example, the screenshot below is of the original Site Plan approval from April, 2000:

There is definitely one new entrance depicted on the proposed AA (and possibly two entrances) which was/were not depicted and approved with the original Site Plan approval or on the October, 2000 AA.

Per 6-4(Z)(1)(a)(3) of the IDO, if a requested change constitutes significant change to the access to the subject property, then the original approving body (EPC) has to approve an amendment. <u>Does the new entrance(s) constitute a significant change to the access? Please confirm.</u>
