Jay,
My understanding is that Mesa Film Studios worked with City Aviation to site the project outside of any known archeological sites and have documentation to that effect that the site is not impacted by any sites. And that City Aviation had surveyed all of DEII property for cultural resources. I'm copying Manny Manriquez from CoA Aviation as they worked closely with Mesa Film on the site selection.
I am going to pull together that documentation. See attached study on UXO's for DEII.

For tribal consultations, we have followed the City's new protocol for tribal consultations and we have documented all of our consultations with tribal entities that we conducted prior to the submittal. That is part of our overall submittal – all impacted Pueblos/tribes were notified through the City's Tribal Liaison and we met individually with Laguna and Santa Ana Pueblos

Hoping that we can sort this out and keep on track with our submittal.

As the agent for the Archaeological Certificate application submitted for the 60-acre site at 7401 Paseo del Volcan NW, attached for your information and records is the Archaeological Certificate signed by the City's acting archaeologist, Doug Boggess, that has been checked "No" for a Certificate of No Effect and "No" for a Certificate of Approval, due to the comments Mr. Boggess provided under the Recommendations section of the signed Certificate. Mr. Boggess has also provided a list of Cultural Resource Consultants in New Mexico for your information which is attached, and is copied in this message (dboggess@lone-mtn.com) for any feedback or questions. Any further required Plans and/or documentation and/or correspondence will need to be provided to Mr. Boggess for his further review and for the issuance of a required Certificate of Approval. Please note that 6-5(A)(1) of the IDO requires an Archaeological Certificate of No Effect or Certificate of Approval to be duly approved prior to approval of any preliminary plat, Site Plan, or Master Development Plan for projects over 5 acres.

As a portion of the site is located within 660 feet of Major Public Open Space (MPOS) per the request received from Rebecca Shank (with your Dekker team) in our Tribal Meeting Request Portal; as the subject property for an Archaeological Certificate located within 660 feet of MPOS requires the offer of a Pre-Submittal Tribal Meeting per Table 6-1-1 and 6-4(B) of the IDO; and as per 6-4(I) of the IDO anything that requires a Pre-submittal Tribal meeting (specifically 6-4(I)(3)) will also need a referral for agency comment, copied in this message as well are tribal representatives as provided by Terry Sloan, the Tribal Liaison with the City's Office of Native American Affairs.
