- a. DRB Description:
SI-2019-00420 – Site Plan.
- b. Site Information: Lots 10A, 11A, 12A, 11B; Unit 1. Paradise Hills Investment Properties Subdivision.
- c. Site Location: 5212, 5216, 5220 Buglo NW between Bash St NW and Sierra Morena St. NW.
- d. Request Description: This is a request for a site plan approval. The site is part of a residential development, the application is for phase 2 of 23 Townhomes, a parking lot, and amenities. The area is approximately 2.49 acres and is zoned MX-L (Mixed Used- Low Intensity).
- e. **APS Case Comments: Residential development at this location will have impacts to Sierra Vista Elementary School, James Monroe Middle School, and Cibola High School.**

To address overcrowding at schools, APS will explore various alternatives. A combination or all of the following options may be utilized to relieve overcrowded schools.

- Provide new capacity (long term solution)
 - Construct new schools or additions
 - Add portables
 - Use of non-classroom spaces for temporary classrooms
 - Lease facilities
 - Use other public facilities
- Improve facility efficiency (short term solution)
 - Schedule Changes
 - Double sessions
 - Multi-track year-round
 - Other
 - Float teachers (flex schedule)
- Shift students to Schools with Capacity (short term solution)
 - Boundary Adjustments / Busing
 - Grade reconfiguration
- Combination of above strategies

All planned additions to existing educational facilities are contingent upon taxpayer approval.
