For an Administrative Amendment (AA) application, you need to submit the following to our office **via email** at this time due to the Coronavirus:

- 2. Letter of authorization from the property owner if application is submitted by an agent.
- 3. Zone Atlas map with the entire site clearly outlined and labeled (go to the following web-site to obtain the required map: https://cabq.maps.arcgis.com/home/webmap/viewer.html?webmap=f12cf8ebe9514a2d8d09e2c7a095d2f4).
- 4. Justification letter describing, explaining, and justifying the request per the criteria in IDO Section 14-16-6-4(X)(2).
- 5. A copy of all applicable sheets of the approved Site Plan being amended (use the previously approved AA you sent me).
- 6. Copy of the Official Notice of Decision associated with the prior approval.
- 7. A copy of the proposed Site Plan, with changes circled and noted.
- 8. A PDF file of the complete application, including all plans and documents, emailed to <u>PLNDRS@cabq.gov</u>, and <u>irodenbeck@cabq.gov</u>. If the file size is over 9 megabytes in size, please send us the submission via WeTransfer at <u>https://wetransfer.com/</u>.

The application fee is \$50. You can pay the fee online (the preferable option at this time) or pay via check, with the check mailed to:

You can pay online once you have submitted your Administrative Amendment application and our office has confirmed reception. Our clerks will direct you to this option at that time if desired.

WeTransfer Instructions:

You will initially be directed to a page which gives you the option of going to the free version of the site (send up to 2 GB at a time), or the subscription-based version of the site (send up to 20 GB at a time). Click on the link to the free version of the site, and you will be directed to the free version of the site (a screenshot of the WeTransfer webpage is attached). Hi Jay,

Thanks again for your time last week and for helping us thru this process. We were able to dig up some of the previous AA submittals. The link below includes the AA submittals and our submitted signage package.

Looking at it now there does seem to be a few differences, and I am hoping to discuss with you exactly what we would need to do to get approval on as much of this as possible as quickly as possible so we can implement the signage once the venue is back under construction.

A few things to consider and what we are looking to see if we can accomplish:

Building Signage

1. Shield Logo - Front of Building

a. Preliminary elevations submitted with AA showed correct graphic scale, but there was a mistake in the dimensions.

b. Approved permit drawings and sign permit application show correct graphic scale, and correct dimensions.

c. Can AA be revised to include corrected elevations showing same graphic scale and the correct dimensions? The size of the signage on the building was accurate in the AA and the scale with relation to the building was accurate but the Dims called out incorrectly by the architect.

- 2. Wall Signs Side Elevations
 - a. AA elevations did not contemplate wall signs on end of tee line
 - b. Can AA be revised to include elevations showing proposed wall signs on east and west elevations?

Freestanding Signage

1. Tierra West (civil) included generic monument sign details and locations in approved AA

2. Can AA be revised to include details for signs that match those in sign permit application now that signs have been final designed?

Any feedback or direction you can provide would be very helpful. Also, my local installer mentioned that he thought the signage we are proposing would all fit within the General Signage allowances for a building with this size and layout, but I don't know for certain if that is accurate and hope you can elaborate.
