Hi Rebecca,

Thank you for helping make some connections here to get more insight on this matter! I am the architect working with Alex on this project.

To add a little more info here, we would like to confirm that the bus lane is fully abandoned and can then be included within streetscape improvements we hope to make along San Mateo Blvd (maybe Carrie or Andrew could weigh in on that).

Assuming that is the case, we would then like to iron out the details of trying to incorporate that area into our re-platted property for the purposes of the mixed use affordable housing development.

The area in question is just under 3,000 SF. We have heard that this may require city council approval, however I also have been told that 5,000 SF of area is usually the threshold that would trigger that action.

FYI – we are planning to submit for a 2nd sketch plat hearing in the next couple weeks largely in order to get more guidance on this aspect of the project, so it would be great to get some additional thoughts now leading up to that.
