## DECLARATION OF PRIVATE COMMON ACCESS EASEMENT

444 THIS EASEMENT is made and executed this 425 day of December, 1991, by New Mexico Educators Federal Credit Union, a New Mexico Corporation (hereinafter called "NMEFCU").

NMEFCU is the owner of the following described real property within the City of Albuquerque, New Mexico:

> Tract E-3, JEANNEDALE ADDITION, Replat of Tracts E & F, Unit 1A, as shown on the plat of said subdivision filed in the Office of the County Clerk of Bernalillo County, New Mexico on December 12, 1986, in Volume C-32, Folio 83 as document number 86-122811.

(hereinafter called "Tract E-3"), and

Tract F-2, JEANNEDALE ADDITION, Replat of Tracts E & F. Unit 1A, as shown on the plat of said subdivision filed in the Office of the County Clerk of Bernalillo County, New Mexico on December 12, 1986, in Volume C-32, Folio 83 as document number 86-122811,

(hereinafter called "Tract F-2").

- NMEFCU does hereby establish a private common access easement across all of Tract E-3 for the use of itself, subsequent lessees, owners, mortagees and others having or acquiring an interest in Tract F-2.
- 3. The easement, rights and privileges granted hereby shall be for the benefit of and be restricted solely to the owner or owners from time to time of all or any portion of Tract F-2, but such owner or owners may grant the benefit of such easement, rights and privileges to its tenants, or affiliates, now or hereafter occupying a building or portions thereof on Tract F-2 for the period of such tenancy, and to the customers, employees and business invitees of said owner or owners and tenants or affiliates, but the same is not intended, and shall not be construed as creating any rights in and for the benefit of the general public. The easement, rights and privileges herein granted shall be used and enjoyed in such a manner as to cause the least possible interference with reasonable business uses of Tract E-3.
- The owner of Tract E-3 shall be solely responsible for maintaining the surface of the common access driveway areas in a good, safe and servicable condition.
