The Preliminary Plat for PR-2023-008674 / SD-2024-00056 had the following conditions of approval which must be met:

c. Show on the Plat that an 8-foot wall, no less than 6 inches wide, with an irregular, not flat, surface that bounces noise, possibly split face block, will be built along the entire eastern property boundary and to wrap around the corner with Lot 4 on Miami Road for a distance of 35-50 feet, stepping down as it approaches the front façade. This condition is partially met with a label for this wall on Sheet 3. Please modify to the exact language above which includes 6 inches wide and the wrap around the corner with Lot 4 on Miami Road for a distance of 35-50 feet, stepping down as it approaches the front façade. This note must be added to Sheet 4 as well. Confirm that the wall drawing on the wall permit document shows at least a 6-inchwide wall.

e. A solid gate shall be provided in the eastern wall to provide access to the trail from the neighborhood.

Provide documentation showing the solid gate design and its location in the wall to provide access to the trail from the neighborhood.
