In the meantime, please send me a copy of the Plat with the application number and DHO approval date added to the Plat as well as the AGIS DXF file approval email per the conditions of approval in the attached NOD. Additionally, we had the following condition in the NOD which must be addressed:

A landscape buffer must be installed either in front of or behind the sidewalk.

I believe the landscape buffer condition needs to be addressed with an exhibit included with the Plat, and might need to be created by a licensed Landscape Architect. Jolene Wolfley and the lead Planner for this Plat, Robert Webb, are copied in this message to provide clarification/confirmation on what we need with this condition.
