Background/Meeting Summary:

This pre-submittal meeting was held in compliance with the IDO-mandated notification of Native tribes when there is development proposed within 660 feet of Major Public Open Space or tribal land. An application is to be submitted to the Development Hearing Officer (DHO) for a Bulk Land Plat dividing one parcel into two and a Preliminary/Final Plat for subdivision of one of the newly-created parcels into residential lots. The 109 acre tract N-1 is owned by Albuquerque Public Schols, which operates Tres Volcanes Community Collaborative K-8 on the eastern portion. They wish to separate the property into a 49 acre tract N-1-A containing the school and a separate 60 acre tract N-1-B to be sold to Pulte Homes, who plan to develop 212 residences on it.

A previous facilitated meeting regarding this property was held 30 January 2025, in advance of an Environmental Planning Commission (EPC) hearing which approved the Site Plan and Variances. (*The report of that meeting, which includes a more detailed review of the site plan, is being sent along with this report.*)

In this meeting, the agent presented a brief review of the proposed development. The homes will reflect the styles of the adjacent Inspiration subdivision, maintaining that look and character. Two access locations from Arroyo Vista will be gated. An additional fence along the Monument boundary at the north will be added. The only access from Savio Ridge to the Monument will be via the existing trailhead at the northwest corner of the school property. It was reported that the West Side Coalition of Neighborhood Associations provided a letter of support for the project—an uncommon occurrence.

Pueblo of Laguna officials and staff expressed considerable distress over the lack of systematic investigating of land—public or private—in advance of development. This has led to destruction of cultural artifacts, which greatly affects them. They provided an extensive review of actions taken in the area in which cultural remains were identified but the tribes were not notified.

Outcome:

Pueblo of Laguna officers expressed appreciation for the opportunity to discuss the proposed project and the efforts of Pulte Homes and Bohannan Huston to conduct the project in a way that balances the business needs of the development with the impact on the petroglyphs. They are not intending to stop development but are standing up so that their precious history and cultural resources are taken into account, especially with all the development on the West Mesa.

Meeting Specifics:

1) Background

- i) APS determined that a High School would not happen at that location and designated the land "surplus," while retaining the existing K-8 school to the east.
 - (1) Pulte Homes was selected as purchaser and builder in a bid competition.
 - (a) They had already developed subdivisions adjacent to the parcel—Inspiration to the west and Del Webb Mirehaven to the northeast.
- ii) Per the IDO, the application to the DHO for the re-plat of this land required notification of Native tribes, as it is adjacent to the Petroglyph National Monument--a major public open space.
 - (1) The proposed application to the DHO includes two items:

- (a) The Bulk Land Plat subdivides the 109 acre Tract N-1 into N-1-A (49 acres to the east) and N-1-B (60 acres to the west).
- (b) The Preliminary/Final Plat subdivides Tract N-1-B into 212 residential lots for development by Pulte Homes.
- iii) The IDO required notification to Native tribes by the City for the EPC hearing on the Site Plan, and notification by the agent for the DHO process.

2) Subdivision Overview

- a) Pulte Homes reports considerable experience with development in this area and with the National Monument.
 - i) They have learned how to treat the edge along the Monument boundary, as well as to control access into the Monument.
 - ii) This Savio Ridge development will reflect the styles of homes in the adjacent Inspiration subdivision.

3) Relation to Petroglyph National Monument

- a) Access into the Monument will be controlled.
 - i) The subdivision itself will have gated access from Arroyo Vista, so that only residents will be able to access the Monument.
 - (1) There will be no direct access from the subdivision into the Monument.
 - (2) Pending approval from APS and AMAFCA, residents will be able to use the existing public South Point Trailhead and parking lot at the northwest corner of the APS school property.
 - (a) There is presently a pedestrian gate and a maintenance road for AMAFCA at that location.
- b) An existing barbed wire fence defines the south boundary of the Monument.
 - i) Pulte intends to install a six-foot high horse fence (wire with 2x4 openings) on wooden posts, to further prevent human entry onto the Monument.
- c) The hills that form the north edge of the subdivision will provide a visual barrier to keep Monument visitors from being able to see the subdivision residences.
 - i) Pulte's plans have removed two lots at the northeast corner of the subdivision and restricted the next three lots to single story only, to further reduce the visual impact of the development on visitors using the adjacent trailhead.
 - ii) Pulte intends to restore the hillsides along that north area severely damaged by ATVs and roads
 - (1) A trail will be developed to the top of the eastern hill, allowing views into the Monument and the city below.
 - (a) There may be small trail light installed, designed to not disturb nighttime viewing.

4) Site Plan Elements

- a) Internally, there will be a 1.7 acre public park for use by residents, in addition to the hillside trail on the north.
- b) Landscaping with trees will be provided along Arroyo Vista, a sidewalk, and asphalt multi-use trails and bike lanes on both sides of the road.
- c) Roadway intersections will have lighting—perhaps solar powered—and in compliance with the City's night lighting ordinance.

5) DPM/IDO Waivers

- a) Several waivers are being requested for the development, that seem normal for this type of development.
 - i) The Design Process Manual (DPM) mandates a maximum roadway block length of 600 feet for vehicular and pedestrian access.

- (1) The westernmost and easternmost roadways do not have provision for such access, due to the boundary conditions with Inspiration and APS, so a waiver is needed.
- ii) Another DPM waiver request asks relief from the minimum curve required of the roadways, along with a reduced dirt right of way along the north side of the northernmost roadway, as there will not be a sidewalk along that edge.
- iii) And additional waiver request involves the IDO prohibition on lots backing up to a roadway classified as a collector or above; Arroyo Vista currently is classified as a principal arterial.
 - (1) The plan calls for 20 foot back yards plus a 20 foot wide HOA-owned buffer from Arroyo Vista.
 - (a) This is to shield the residents from the roadway.
- iv) While sidewalks will be provided along the roads in front of residences, Pulte is asking that those sidewalks be deferred until construction in any area is finished, to prevent their being damaged.

6) Cultural Impacts and Notification

- a) The area was tribal land and so development ultimately impacts the Native way of life.
 - i) There are pathways that connect tribes from their current locations into the petroglyphs.
 - ii) A letter from the City archaeologist is disturbing to the tribes, as it indicates sites that were excavated and damaged, without notification to tribes or attempts at mitigation.
 - (1) The current location of anything excavated in that area is not known.
 - (2) While no longer owning the land and not being able to protect the high density of cultural resources, tribes depend on other agencies.
 - (a) The State Historic Preservation Office does not undertake the required work to ensure that there are no cultural remains prior to development.
 - (i) SHPO checks written records but does no field investigation.
 - iii) There have been surface surveys noting lithic materials, fire rings, and pottery, though subsurface investigation has not taken place.
 - (1) APS had surveys conducted by Western Albuquerque Land Holdings when they acquired the land.
 - (a) 31 archaeological sites were located and determined potentially eligible for inclusion in New Mexico State Register for Cultural Properties in the National Register of Historic Places.
 - (i) 12 of these are within two parcels selected by APS for development of the westside school and recreation facilities.
 - (2) Three reports followed those surveys.
 - (a) ACTION ITEM—The agent will locate those surveys and make them available to the Pueblo of Laguna.
 - (3) There are no restrictions on private land—owners can excavate without giving notice of what they find; it is an honor system.
 - (a) In the Mimbres Valley, a village was discovered, with artifacts and human remains that were repatriated—an example of what can be found.
 - iv) Addressing the concerns expressed, Pulte will ensure that their contractors and subcontractors immediately stop work if and when cultural artifacts are discovered, and provide notice so that mitigation can take place.
 - The contractors do not want the liability that comes from ignoring the requirements in the City's Archaeological ordinance, for taking action when cultural remains are discovered.
 (a) Albuquerque does better than most cities but the process is still imperfect.
 - v) For tribes, there are very serious issues when development happens
 - (1) It affects them not just physically but also spiritually.
 - (a) Tribal members carry spirituality no matter where they come from.

Next Steps:

A hearing before the DHO for the Bulk Land Plat application may be held as soon as 9 April 2025, with the Preliminary/Final Plat application heard then or soon thereafter.

Action Items:

The agent will provide copies of the three summary reports from archaeological investigations conducted in the area.

Development Hearing Officer (DHO):

The DHO is charged with administering the Integrated Development Ordinance (IDO) and the Development Process Manual (DPM) as well as other City ordinances and policies applicable to subdivision actions. 





BULK LAND PLAT SITE LOCATION







BULK LAND PLAT SITE LOCATION




