Hi Kevin,

Thanks for sharing the proposed fence and wall information with Petroglyph National Monument. We are in support of this type of fence as from an enforcement perspective, it would likely be decent at deterring trespassing which is beneficial for the Monument and for the community.

We would suggest installing the base of the fence around 3-4" above ground level so as not to trap small mammals. It's hard to see from the photos whether the openings in the fence would be large enough for small mammals and lizards to travel through, so installing the base slightly above the ground would allow small animals to get through without being trapped.

The less "shiny" the better as well - so that rust color may work well, or if the fence would fade/patina over time, that'd work as well.

We also have no issues with the proposed walls.

Clarification - Once installed and once the Pulte project is completed, would the HOA/NA be responsible for long-term fence maintenance?

We are requesting you all reply to this email with either comments or your approval of our proposed fencing detail along the boundary with your properties. The city is requesting your acceptance of the boundary fencing prior to final approval.

The enclosed pdf exhibit reflects a red line that is a view fence adjacent to the property line with the NPS and APS. The view fence is five to six feet high with metal fencing and timber posts (see enclosed pic). The metal fencing can be a rust color if you would rather have the rust coloring. The blue line is our rear perimeter fencing or wall that will be split face cmu block that looks similar to the perimeter wall that exists today on the community to the west. We are looking to flip the color possible. I've enclosed a screenshot showing that wall.
