Good afternoon Jay and Members of the DHO,

I am writing to formally update the City on our application regarding the pending Subdivision Platting action for the property located at Paseo del Norte and Kimmick (PR-2025-020092)

After careful consideration, and in the interest of complete transparency and collaboration, we have modified our request. We are hereby **removing all subdivision components from the application in its entirety**. The revised plat now seeks only the establishment of necessary easements and right-of-way (ROW) dedications along Paseo del Norte.

This modification significantly narrows the scope of the action and eliminates the elements that were the subject of opposition. There are no lot splits, no changes to tract configuration, no impacts to the VPO Height Restrictions and no subdivision-related modifications being requested whatsoever. The revised application is strictly administrative in nature and limited to infrastructure and dedications necessary along Paseo del Norte.

To ensure clarity and a clean administrative record, we have included the following updated materials:

- Updated Project Request Letter clearly outlining the revised scope
- Updated Plat Document reflecting removal of subdivision actions
- Updated Sensitive Lands Analysis

By narrowing the request to easements and ROW dedication only, we believe we have addressed the procedural and policy concerns that were previously raised. Our goal is to move forward in a manner that is technically sound, transparent, and aligned with the requirements of the IDO.
