The corresponding NOI was certified on 6/16/2021 and became active on 6/30/2021. The corresponding NOI selected Criterion A on the basis that the USFWS Species Report and IPaC Habitat Map indicate there are no critical habitats in the project area. The nearest critical habitat is approximately 3.85 miles southeast of the project, point - to - point. The identified species that exists in the habitat is not likely to be adversely impacted because the noted receiving waters is dry the majority of the year and unlikely to experience a storm event producing enough flow to carry any discharge to the habitat. The habitat and various project locations are also separated by the city buildings, roadways, irrigation channels and railroads, minimizing the potential for discharge to reach the habitat. Additionally, the endangered species is an aquatic species and will not be able to travel up to the project area
