The particular nature, location, and scope to the proposed development defines the degree of drainage detail. One or more of the following levels of submittal may be required based on the followin

1. Conceptual Grading and Drainage Plan: Required for approval of Site Development Plans greater than five (5) acres and Sector Plans

- Drainage Plans: Required for building permits, grading permits, paving permits and site plans less than five (5) acres
- Drainage Report: Required for subdivision containing more than ten (10) lots or constituting five (5) acres or more
- Erosion and Sediment Control Plan: Required for any new development and redevelopment site with 1-acre or more of land disturbing area, including project less than 1-acre than are part of a larger common plan of development

Subject: Liberty Dialysis on Pinon Verde and McMahon

Nilo and Shahab, based on our meeting this morning, it was discussed that the Paving Contractor at Liberty Dialysis did not construct with driveway (along Bandelier or Pinion Verde) exactly as shown on COA standard drawing 2426. The aprons, as they enter the site, were not installed and placed monolithically with the curb and gutter. Both entrances serve as water blocks and the site is graded to not surface drain out of these drive entrances but rather out proposed sidewalk culverts. Due to this circumstance, it was determined that the existing curb and gutter currently in place does not need to be removed and replaced to include the aprons but rather could be left in place. In addition it was noted that the new stamped concrete will be required to be ADA compliant.

Lastly the handicap ramp at the south side of the Bandelier Entrance was noted as being constructed incorrectly and not per the COA standards. This HC ramp has been removed and replaced to adhere to COA standard drawings.

Please let me know if I have stated anything incorrectly. Thanks again for your time.
