Lynn,

Attached is our most current grading & drainage plan for your file. We are no longer proposing a storm drain outfall to the arroyo since the existing system which runs parallel to and across Golf Course Road (from Smith's) has capacity, according our analysis. A portion of the existing storm drain from the apartments (System B) will be reconstructed to allow for the grading design, however, no work is proposed within the Arroyo.

As for the Infrastructure List, we can include a water quality manhole at "Node 7" (see proposed basins exhibit), unless you feel an additional water quality manhole is warranted for System B (we are only connecting a small private area drain from the plaza and roof drains- no parking lot areas). I think the Private SD License will not be necessary.

I have not seen the current grading plan. We already have the signed Funding Agreement for the Calabacillas Arroyo improvements, so I don't think that needs to be on the IL. As you may recall, AMAFCA will construct the improvements, and Spectrum will provide funds for their section. On an earlier plan, they showed a storm drain outfall to the arroyo. We will need a water quality manhole or structure and a Private Storm Drain License for the storm drain. Those 2 items should be on the IL.
