The USFWS Species Report and IPaC Critical Habitat Map indicate there are no T&E species or critical habitats in the action area. The nearest habitat is approximately 4.2 miles southeast of the project. The species and habitat are not likely to be adversely impacted as the onsite discharge enters an existing retention system where it will stay and eventually evaporate. The habitat is preceded by other municipal retention ponds, thereby minimizing the possibility the discharge will ever meet the habitat.
