<u>District Three Traffic Section</u> This correspondence is to inform you that the NMDOT recognizes that the utility was installed with the Larry H. Miller commercial development expansion, and is currently capped and out of services. Considering this is a utility currently not in use the NMDOT shall not issue a permit for said utility. The NMDOT shall be notified prior to the utility being connected so that the utility can be evaluated against the utility permit process procedures. All NMDOT comments shall be addressed prior to utility hook up and issuance of utility permit.

Please note that the fully executed utility permit will be returned to you as soon as we receive the required As-Built Plans and the Electronic File. These items are required within 30-thirty days of completion of your installation.

You are required to notify Peter Kubiak via email: peter.kubiak@state.nm.us by completing the attached Traffic Control/ Roadway Work Permit Form at least five (5) days in advance of construction. Upon receipt of an approved Traffic Control Permit you will have permission to enter the NMDOT Right of Way.

Should you find it necessary to deviate from the proposed installation or approved TCP, any such deviation must have written approval by the District Three Office prior to proceeding with construction. All work performed must meet or exceed the NMDOT's Standard Specifications for Highway and Bridge Construction, 2014 Edition. In addition to the above requirements:

- The Traffic Control Plan and all traffic control devices used by the owner and Contractor must comply with Part VI of the Manual on Uniform Traffic Control Devices (MUTCD) 2009.
- The utility owner and contractor shall abide by Section 12.0 through 12.5 of the NMSH&TD Utilities Manual under <u>General Utility Construction</u> Requirements.
