The corresponding NOI was submitted on October 29, 2020 and authorized on November 12, 2020. The Operator for NOI NMR1002JR selected Criterion C. The USFWS Species Report and IPaC Critical Habitat Map indicate there are no critical habitats or T&E species in the action area. The Rio Grande Silvery Minno and Yellow - Billed Cuckoo habitats are approximately 1.6 and 1.2 miles west of the site, point - to - point. The project area does not provide the preferred habitat for either species and is unlikely to attract or adversely impact the habitats.
