- How will the west portion of the site drain? Why not locate the outfall (or another outfall) at the west 1: end?
- 2. The detail for a channel penetration is incorrect. This detail is for a small diameter ductile iron pipe. I (well need to be modeled for your alignment et have attached a standard detail that you can use.
- Martin Eckert of our office will prepare the license agreement for the Nitrogen line crossing. We need 3. additional 8.5x11 exhibits showing the location of the line in plan view and a complete cross section of the channel showing the entire channel prism. These will be attached to the license agreement. The license will not go before the Board and will be executed by our Executive Engineer. If boring pits are required, these should be shown on the plans.
- A license is not required for the 24 inch penetration because this will be a publicly maintained pipe. 4. AMAFCA must sign the appropriate construction mylars as part of the approval process.
- I have included a storm sewer permit form for you and the contractor. Please add an appropriate note 5 to the plans explaining this process and the insurance requirements for the contractor, so that the contractor will complete it prior to construction. You can prepare your own note and add "contact AMAFCA at 884-2215 at least 48 hours prior to construction".


