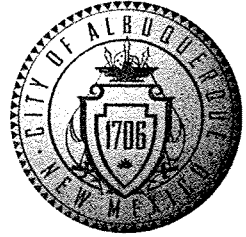



Graeme Means, NMPE 13676, of the firm High Mesa Consulting Group hereby certify that the traffic circulation elements have been constructed in substantial compliance with and in accordance with the design intent of the approved plan dated 05/06/2008. In addition to documenting conformance with the approved plan, this submittal documents the locations of additional sidewalks, patios, landscaping, and the track area which were added to the project during construction.

The record information manually edited onto the original design document in blue is taken from the Topographic and Utility Survey of Tract C-1 Ancient Mesa Tony Hillerman Middle school dated 12/01/2009 prepared under the direct supervision of Charles G. 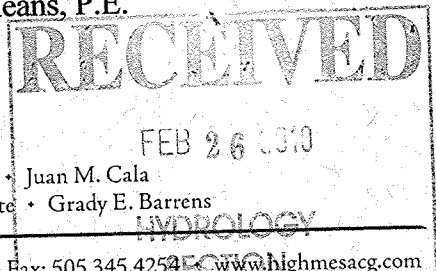
