 - Proposed driveway design shown, curb return design, needs to reference COA std dwg 2426 (need to show 6 ft valley with 1 inch invert) instead of 2425B.
 Please adjust note.

 Clear sight triangle will need to be 11 ft by 11 ft from back of sidewalk. Adjust on site plan.

- The maximum entrance width shall be 30 ft only. Please reflect on site plan.
- Provide the radiuses for the proposed driveway entrance.

ADA curb ramps must be updated to current standards and have truncated domes installed.

- 13. Motorcycle parking spaces shall be designated by its own conspicuously posted upright sign, either free-standing or wall mounted per the zoning code. Label pavement MC.
- 14. All bicycle racks shall be designed according to the following guidelines:

- a. The rack shall be a minimum 30 inches tall and 18 inches wide.
- b. The bicycle frame shall be supported horizontally at two or more places. Comb/toaster racks are not allowed.

- c. The rack shall be designed to support the bicycle in an upright position. See the IDO for additional information.
- d. The rack allows varying bicycle frame sizes and styles to be attached.
- e. The user is not required to lift the bicycle onto the bicycle rack.
- f. Each bicycle parking space is accessible without moving another bicycle.
- 15. Bicycle racks shall be sturdy and anchored to a concrete pad.
- A 1-foot clear zone around the bicycle parking stall shall be provided.
- 17. Bicycle parking spaces shall be at least 6 feet long and 2 feet wide.
- 18. List radii for all curves shown; for passenger vehicles. Radius for delivery trucks, fire trucks, etc. is 25 ft. or larger.
- 19. Per the DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the public sidewalk to the building entrances. Please clearly show this pathway and provide details.

- 20. Per DPM, a 6 ft. wide ADA accessible pedestrian pathway is required from the ADA parking stall access aisles to the building entrances. Please clearly show this pathway and provide details.
- 21. ADA accessible pedestrian pathway should not be placed behind parking space or adjacent to a vehicular way. Vehicle and pedestrian/wheel chair conflicts should be avoided as much as possible.
- 22. Curbing should be installed to delineate landscape, parking, and pedestrian ways and identify points of access. Please call out detail and location of barrier curb.
- 23. Provide a copy of refuse approval.
- 24. Fire Department: An approval Fire 1 plan needs to be provided.
- 25. Please provide a sight distance exhibit (11ftx11ft from back of sidewalk).
- 26. Show the clear sight triangle and add the following note to the plan: "Landscaping and signage will not interfere with clear sight requirements. Therefore, signs, walls, trees, and shrubbery between 3 and 8 feet tall (as measured from the gutter pan) will not be acceptable in the clear sight triangle.
