The TCL submitted is sufficient for acceptance by this office and is stamped and signed as such. Four copies will be required: two for submittal of building permit plans, one for this office [please leave with the front counter staff, at permitting, to be placed in Transportation bin]. Keep one, to be used for certification of the site, for final C.O. for Hydrology/Transportation.

When superintendent of project is ready to call for a TemporaryFinal C.O. immediate issuance is no longer possible at that time. An <u>exact</u> copy of the approved TCL, marked up, showing incomplete work remaining, along with a letter of certification, is required prior to issuance of Temp C.O.

When site is complete and a Final C.O. is needed, a Letter of Certification, stating site was built in substantial compliance, needs to be attached to your stamped, approved TCL. All documentation must be submitted with a completed Drainage Information Application sheet also used for the Grading & Drainage submittal to Hydrology at the Development Services Center of Plaza Del Sol Building.

The above referenced drainage plan received October 10, 2001 is approved for Building Permit. I understand that the Building Permit has to be released a soon as possible because of upcoming requirements. However, The street grades have not been submitted or approve by DRC. Therefore, my first comment is not completely addressed. Please coordinate the future street grades with the Building Permit site grades. The Certificate of Occupancy cannot be released until the street grades are approved at DRC. Also, the engineer needs to certify the project prior to release of Certificate of Occupancy. I have attached the sidewalk culvert detail. Please indicate on the DRC drawings the width and length of the sidewalk culvert.

Dear Mr. Losinski:

The above referenced drainage plan received September 7, 2001 is approved for Site Development Plan for Building Permit Approval. The following approvals are needed for the project.

- 1. Prior to Building Permit approval the Site Plan would have to be approved.
- 2. The DRC would need to approve the street improvements. The sidewalk culvert would be approved with the construction plans at DRC, therefore, there is no need for the SO #19.
- 3. There is platting involved with the street, which needs to go through the DRB.

Items that have to be addressed prior to Building Permit release for Hydrology would be the following.

- 1. Show the proposed curb and gutter grades on the drainage plan.
- 2. Please show more details for the sidewalk culvert. There appears to be a conflict with the fire hydrant and the telephone box. It may be easier to place the sidewalk culvert perpendicular to the street.
- 3. Please address how you will keep the sediment out of the street from the proposed sidewalk culvert area.






