The corresponding NOI was certified on 9/4/2020 with anticipated activation on 9/18/2020. The NOI selected Criterion C on the basis the USFWS Species Report and IPaC Critical Habitat map indicate there are no critical habitats or species in the project area. The nearest habitat is approximately 3.4 miles west of the project, point - to - point. The noted receiving waters intersect with various canals and irrigation ditches prior to intersecting with the habitat. The receiving waters are also dry the majority of the year and will likely remain dry during the remainder of construction as it will occur outside monsoon season. The project activities are not likely to adversely impact the species or habitat.
