Provide a brief summary of the basis for criterion selection listed above (the necessary content for a supportive basis statement is provided under the criterion you selected.):

Consultation with USFWS identified a total of 5 threatened, endangered, or candidate species in the project area. There were no critical habitats within the project area under USFWS jurisdiction, a copy of the inquiry and response can be found in Appendix K of SWPPP. Consultation with the New Mexico Department of Game and Fish resulted in a determination that the project "as proposed is unlikely to adversely impact wildlife or wildlife habitats" provided that listed recommendations are followed. A copy of the inquiry and response can be found in Appendix K of SWPPP. In addition to the preceding, a visual inspection was conducted on February 20, 2019. None of the 5 threatened, endangered, or candidate species were observed within in the project area. Furthermore, the project is an infill/redevelopment project in an urbanized and previously developed area with little or no natural habitat. Lastly, the site discharges directly to the City of Albuquerque MS4 via subsurface pipe storm drainage conveyances.

New Mexico Meadow Jumping Mouse, Mexican Spotted Owl, Southwestern Willow Flycatcher, Yellow-billed Cuckoo, and Rio Grande Silvery Minnow
