



Dear Mr. Biazar.

The following are responses to your comments provided on August 18, 2011. These responses are direct answers to your comments, and should serve to help you find the locations on the plans of the appropriate corrections and/or revision.

- SO-19 approval now requested.
- The address is 1311 Cuesta Arriba Ct. NE
- The site was analyzed using the COA DPM process for watersheds 40 acres and less. A spreadsheet has been set up to facilitate calculations. All input parameters are shown on sheet C-100, table 1. Results of spreadsheet calculations are also shown on sheet C-100.
- City drainage file (D-16/D002C) now provided on sheet C-100 in sections I, III and X.
- The total discharge (4.79 cfs) is now provided on sheet C-100 in sections I and X.
- SO-19 construction notes and signature block now provided on sheet C-101.
- Sidewalk culverts within the ROW are now referenced to COA Standard Detail 2236, latest edition. On-site culverts are referenced to detail-13 shown on sheet C-103.
- Sidewalk culvert plate within the ROW has been extended to back of curb.
- Culverts calculations shown on sheet C-100 are now analyzed with the orifice equation.
- Boundaries shown on sheet C-100 for all areas are now thickened.
- Spot elevations for refuse area are now provided.

- Parking spaces and HC parking are now shown on sheet C-102.
- All door locations to the outside are now shown on sheet C-101.
- The runoff within the westerly landscaped area is now routed to the on-site pavement through a three foot curb cut (sheet C-101).
- All mark-ups and comments have been addressed.
- General note #24 on sheet C-101 now indicate all landscaped areas to be depressed approximately six inches

- Also use the orifice equation for sizing the sidewalk culvert.
- Thicken the boundaries for drainage Section A, B, & C.
- Please provide spot elevations for the trash enclosure.
- Please show parking spaces and handicap parking area.
- Please show the door locations for the building.

Drainage Facilities within City Right-of-Way Notice to Contractor

- 1. An excavation permit will be required before beginning any work within City Right-Of-Way.
- 2. All work on this project shall be performed in accordance with applicable federal, state and local laws, rules and regulations concerning construction safety and health.
- 3. Two working days prior to any excavation, the contractor must contact the line locating service, New Mexico One Call 260-1990, (NM one call "811") for the location of existing utilities.
- 4. Prior to construction, the contractor shall excavate and verify the locations of all obstructions. Should a conflict exist, the contractor shall notify the engineer so that the conflict can be resolved with a minimum amount of delay.
- 5. Backfill compaction shall be according to traffic/street use.
- 6. Maintenance of the facility shall be the responsibility of the owner of the property being served.
- 7. Work on arterial streets shall be performed on a 24-hour basis.

NOTICE TO CONTRACTORS

- 1. AN EXCAVATION/CONSTRUCTION PERMIT WILL BE REQUIRED BEFORE BEGINNING ANY WORK WITHIN CITY RIGHT-OF-WAY.
- 2. ALL WORK DETAILED ON THESE PLANS TO BE PERFORMED, EXCEPT AS OTHERWISE STATED OR PROVIDED HEREON, SHALL BE CONSTRUCTED IN ACCORDANCE WITH CITY OF ALBUQUERQUE INTERIM STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION, 1985.
- 3. TWO WORKING DAYS PRIOR TO ANY EXCAVATION, CONTRACTOR MUST CONTACT NEW MEXICO ONE CALL FOR LOCATING SERVICE, 260-1990 OR "811", FOR LOCATION OF EXISTING UTILITIES.
