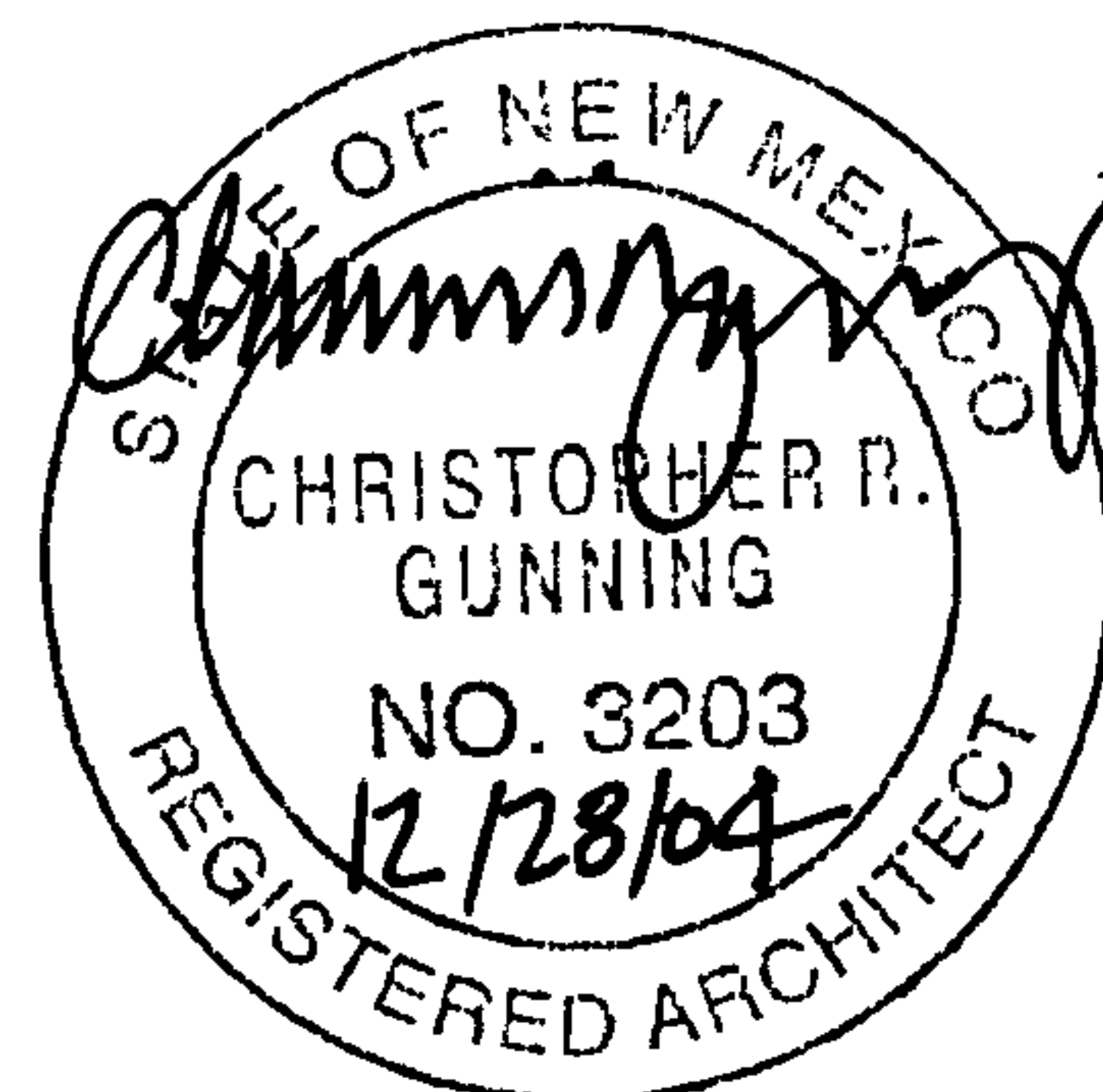
Based on our observations we hereby certify that this site has been constructed in substantial compliance with the approved Site Development Plan for Building Permit, with the following exception:
