NOI selected Criterion C on the basis that the USFWS Species Report and IPaC Critical Habitat
map indicate there are no T&E species in the action area. The nearest critical habitat is 3.75 miles
west of the project, point - to - point. The habitat is not likely to be adversely impacted as the
project discharge enters an arroyo thence the AMAFCA North Channel. The North Channel
detains municipal runoff prior to the habitat area. The discharge is not likely to meet the habitat
due to the MS4 ponding system.
