- The concrete contractor is washing out in the dirt. I spoke to the driver, he said that the foreman told him to
 wash out in that location. The washout concrete is to be removed and if more concrete work is planned an
 acceptable wash-out area is to be provided.
- 2. The inlet protection on the north inlet needs maintenance.
- The SW inlet is perched a few inches above grade, but by estimating the contributing basin it did not seem high enough to prevent sediment from entering it. I recommend providing a larger volume below the grate elevation or using standard inlet protection.
- 4. The upper half of the site was paved before the lower half. It is too late to change that now, but it would have been preferable to pave the lower half first as the upper portion impervious area will drain onto the dirt area.
