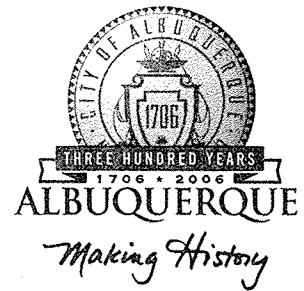

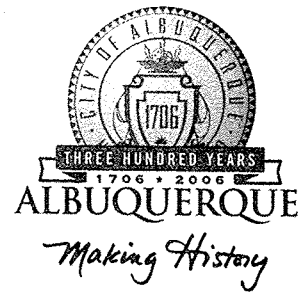

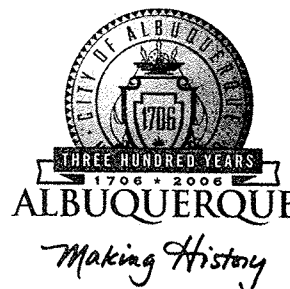

Prior to Certificate of Occupancy release, Engineer Certification per the DPM checklist will be required. **The SO#19 Inspector's approval must be received before a final Certificate of Occupancy can be issued.**
