ACCESS, EGRESS AND DRAINAGE AGREEMENT

THIS COVENANT made this 26th day of August, 1992, by and between:

F. RICHARD ZEMKE. PRESIDENT OF GARDNER-ZEMKE COMPANY, OWNER of Lot 13 numbered Thirteen (13), in Block numbered Five (5), Tract "A", Unit "A", NORTH ALBUQUERQUE ACRES, a subdivision to the City of Albuquerque, Bernalillo County, New Mexico, as the same is shown and designated on the plat of said subdivision filed in the office of the County Clerk of Bernalillo County, New Mexico, on the 17th day of MARCH., 1937, (BK. 10, P.129),

AND

F. RICHARD ZEMKE, PRESIDENT OF GARDNER-ZEMKE COMPANY, OWNER of Lot numbered Fourteen (14), in Block numbered Five (5), Tract "A", Unit "A", NORTH ALBUQUERQUE ACRES, a subdivision to the City of Albuquerque, Bernalillo County, New Mexico, as the same is shown and designated on the plat of said subdivision filed in the office of the County Clerk of Bernalillo County, New Mexico, on the 11th day of MARCH 1937, (BK.D , P. 129).

The OWNER, (which term includes successors and assigns) of said Lot numbered Thirteen (13), grants to the OWNER of said Lot numbered Fourteen (14) the right of usage, access and egress from the said Lot Fourteen (14) to existing improvements on Lot Thirteen (13), which existing improvements include the parking aisles, refuse bin and curb cut along the southerly right-of-way of Pino Avenue N.E..

The OWNER, (which term includes successors and assigns) of said Lot numbered Thirteen (13), grants to the OWNER of said Lot numbered Fourteen (14) the right to convey storm runoff over and across said Lot Thirteen (13), together with any drainage from watering any landscape or any other ordinary domestic use across the common boundary line of said properties.

This ACCESS, EGRESS AND DRAINAGE COVENANT is binding upon the Owner(s), their heir(s) and assigns, and will continue to run with said properties until such time as an alternate drainage plan has been approved by the City of Albuquerque - Hydrology Department, and this document is released by a recorded document having been signed and acknowledged by the Owner(s) of the above described real properties.
