

The Engineer's Certification does not comply with the DPM checklist.

- 1. Indicate the as-built elevations on the Plan. Typically this is done by putting a line through the proposed elevation and writing the as-built elevation next to the proposed. If the as-built elevation matches the proposed exactly a checkmark may be placed by the proposed instead.
- 2. The Certification Statement is worded incorrectly. It should be "substantial compliance" instead of "essential compliance".
