
The TCL submittal, dated June 17, 2002, is sufficient for acceptance by this office and is stamped and signed as such. Four copies were to be produced: two placed in building permit plans, one for this office and one should be kept by you to be used for certification of the site for final C.O. for Hydrology/Transportation.

Inform the superintendent of this project that when he calls for a Temporary C.O. (Temp) immediate issuance is no longer possible at the time of the call. An acceptable copy of the approved TCL--marked up, showing work remaining to be completed, along with a letter of certification--is required prior to issuance of the Temp. Letter and/or TCL (Cert), must be stamped with the designer's seal for the Cert. Seal must be signed and dated for that Cert. This and all documentation must be submitted with a completed Drainage and Transportation Information Sheet (also used for the Grading and Drainage submittal) to Hydrology at the Development Services Center of Plaza Del Sol Building. When site is complete and a Final C.O. is needed, a Letter of Certification, stating (including the word "Certify/Certification") that the site was built in substantial compliance, needs to be attached to an exact copy of the stamped, approved TCL. Another copy similar to the TCL is acceptable, however, more time will be required to verify the copy before issuing the Final C.O. DRB Site Plans must be exact copy, with DRB signature block. Letter or TCL must be stamped with the designer's seal for the certification. Seal must be signed and dated for that certification. Submit Cert. with a completed Drainage and Transportation Information Sheet to Hydrology. A second, acceptable option -- place a typed or stamped Statement of Certification on the approved TCL copy -- can be used as the Cert. Letter and/or TCL in the Cert. must be stamped with the designer's seal, signed and dated for that Cert. The Drainage/Transportation Information Sheet must be filled out fully ("surveyor" or "contractor" are not as crucial), so other parties that may need to be contacted are listed.

When the Cert. is being submitted by a representative sent by the designer-of-record, that representative must have a fully completed copy of the Drainage and Transportation Information Sheet to submit with the Cert or that representative must have the information to fully complete the sheet for the submittal.

Once verification of certification is completed and approved, notification will be made to Building Safety to issue Final C.O. To confirm that Final C.O. has been issued to the superintendent, call Building Safety at 924-3306.
